# NT proBNP testing in NHS Scotland 2020

### **Background**

SCBN received an enquiry from the Scottish Pulmonary Vascular Unit, Glasgow (National service) regarding the availability of NT proBNP testing in Scotland. Given the pandemic they are looking at ways in which they may be able to remotely monitor their patients without them having to travel.

The network last surveyed availability and use of Natriuretic Peptides back in 2017. At that point both BNP and NTproBNP tests were in use and there was also variation in whether the tests were available to secondary or primary care.

### Aim

To establish a more up to date snapshot of the availability of NTproBNP testing across NHS Scotland and also capture key information on which population (primary care /secondary care /both) this was available to and to ascertain any restrictions to the use of the test.

#### Method

This enquiry was raised as an item at the August Steering Group meeting with responses requested from all boards.

#### **Results**

## Discussion

Responses were received from 13/14 NHS Scotland boards. NTproBNP testing is now performed in all bar one of these 13 boards. The remaining responder board referred secondary care requests (once vetted) to a neighbouring board.

NT proBNP is available to primary care in 10/13 responder boards (exceptions are Ayrshire and Arran, Fife and Lanarkshire) and it is used according to a defined heart failure diagnostic pathway. The test is also available in 11/13 responder boards to secondary care (exceptions are Borders and Tayside), although generally to restricted clinics/services, such as Cardiology. Tayside have a business case in progress to roll out NTproBNP testing to secondary care.

Survey results will be fed back to the Scottish Pulmonary vascular unit.
